PRINCIPAL INVESTIGATOR AND LEAD METHODOLOGIST | Diaper Distribution Demonstration and Research Pilot (DDDRP) Evaluation | Administration for Children and Families (ACF), U.S. Department of Health and Human Services (HHS)

Westat is conducting a 5-year evaluation to understand the DDDRP implementation and design a future effort to measure the program's causal impacts. Innovations in the approach include using an online platform to track project progress, timeline, and assignments and a caregiver panel of 4-6 people with lived diaper need expertise to provide feedback and complement our active engagement with interested community organizations. The DDDRP evaluation will add to the small

body of existing evidence on diaper distribution programs and the benefits children, their caregivers, and families gain from having a secure source of diapers.

PRINCIPAL INVESTIGATOR (WESTAT) AND ADVISOR (ETP) | Research and Evaluation Technical Partner to the Guaranteed Income Coordinating Council (GICC) | Conrad N. Hilton Foundation

The Los Angeles Guaranteed Income Coordinating Council (GICC) coordinates work between approximately ten guaranteed income pilot projects in Los Angeles County, developed with public and private financial support, to test the benefits of guaranteed income across different areas of the county and for several populations living at or below the poverty, including families, pregnant women, youth, youth transitioning from foster care, and seniors. Pilots typically include randomized studies and involve a range of income amounts and for varying periods of time. As the evaluation and technical assistance partner, Westat synthesizes, shares, and applies information and knowledge about the collective impact of guaranteed income pilots. Work includes co-creating a shared learning agenda, providing technical support to local program evaluations, documenting best practices and lessons learned, and synthesizing the evaluation findings of these diverse projects.

PRINCIPAL INVESTIGATOR | Supportive Housing Individualized Placement and Support (SHIPS) | Social Security Administration (SSA)

The SHIPS project is a cooperative agreement with SSA investigating the impact of the addition of the employment intervention, Individualized Placement and Support (IPS), in supportive housing on employment and housing stability. The project is a randomized experiment comparing IPS with employment services as usual in supportive housing.

PRINCIPAL INVESTIGATOR | Evaluability Assessment of the Regional Pediatric Provider Network | Health Resources and Services Administration (HRSA)

Westat conducted an evaluability assessment with the Regional Pediatric Pandemic Network (RPPN) and key stakeholders to determine the feasibility of program evaluation and the best approach to evaluation design. The project include **d** a literature review and environmental scan of pediatric readiness and disaster preparedness, a stakeholder analysis, an evaluability assessment, and the development of an evaluation design.

PRINCIPAL INVESTIGATOR (WESTAT) AND ADVISOR (ETP) | Evaluation of the Hilton Foundation's Strategy 25 Homelessness Initiative | Conrad N. Hilton Foundation

Westat is evaluating the Hilton Foundation's Strategy 2025 (S25) Homelessness Initiative, which seeks to address the problem of chronic and long-term homelessness in Los Angeles County, making homelessness rare, brief, and non-reoccurring. The evaluation involves tracing the role of the S25 Initiative in contributing to progress over time in preventing and ending homelessness in Los Angeles County. The study uses a mixed-methods evaluation approach, integrating the perspectives and voices of a diverse array of community partners with findings from administrative data. Activities include bi-annual interviews with key informants and focus groups with people with lived experience; annual web-based survey of the Hilton Foundation's partners and grantees; analysis of the HMIS and other administrative data; routine contacts, including briefings and listening sessions; and the development of annual reports and other dissemination products.

PRINCIPAL INVESTIGATOR | Addressing Homelessness Among Older Adults | Assistant Secretary for Planning and Evaluation (ASPE), U.S. Department of Health and Human Services (HHS)

Westat conducted an environmental scan of the literature on the characteristics and needs of older adults experiencing or at risk of homelessness and the services, housing, and supports needed and available to serve them. In conducting the scan, Westat used a systems perspective outlining the services and supports needed across different service delivery systems and an equity lens to examine what is known about whether older adults in racial and ethnic groups are disproportionately impacted by homelessness as well as the extent to which services and housing are equitably provided. PRINCIPAL INVESTIGATOR | Chafee Strengthening Outcomes for Transition to Adulthood (Chafee SOTA) | Administration for Children and Families (ACF), U.S. Department of Health and Human Services (HHS)

Westat is conducting this project in collaboration with the Kempe Center for the Prevention and Treatment of Child Abuse and Neglect (University of Colorado School of Medicine), Dr. Katie Richards-Schuster (University of Michigan, School of Social Work), CLH Strategies & Solutions, and First Place for Youth. The project aims to develop and implement innovative learning methods appropriate to study promising practices in Chafee-funded programs. The ultimate aim is to strengthen the evidence base and improve the feasibility and rigor of evaluations. The project involves conducting learning activities to identify information needs, evaluation challenges, and promising approaches; process for identifying and engaging youth-serving programs to participate in evaluation activities; examining the evaluability of promising approaches; and testing innovative methods in examining the effectiveness of these promising practices in serving youth transitioning from foster care.

Dr. Rog led the design and training for the evaluability assessments of candidate programs, and is leading the design of innovative, nontraditional effectiveness studies, including single-subject designs, interrupted time series, and stepped wedge designs.

PRINCIPAL INVESTIGATOR | Culture of Health Progress Report | Robert Wood Johnson Foundation (RWJF)

The goal of this project was to assess the uptake and spread of RWJF's foundation wide strategy to build a Culture of Health. The evaluation created a theory of change collaboratively with the Foundation that is being used by both the Foundation and the evaluation to guide the work and

assess the Foundation's contribution to building a Culture of Health. The evaluation involved studying the Foundation's evolution of addressing equity and structural racism, and its progress in achieving short- and long-term outcomes in its theory of change. Evaluation activities included conducting key informant interviews, reviewing and analyzing grants funded, synthesizing evaluations, and examining the process of infusing equity into evaluation.

Dr. Rog led all aspects of the study, including initiating and guiding the developments of the Foundation's theory of change, and designing all study components.

PRINCIPAL INVESTIGATOR | Evaluation of the Youth Homelessness Demonstration Program (YHDP) | U.S. Department of Housing and Urban Development (HUD)

In January 2017, HUD awarded \$33 million to 10 communities through the YHDP, designed to facilitate the development of coordinated systems for preventing and ending youth homelessness. Westat conducted a 4-year evaluation to examine how the communities are developing and implementing coordinated systems and how these systems are affecting the size and composition of the target population (youth who are homeless or at risk of homelessness, including pregnant/parenting, LGBTQ, and minor youth). Westat performed site visits to the 10 YHDP sites and to 3 comparison sites, a web survey of all other communities across the country that have implemented a continuum of care approach, and analysis of each site's homeless management information system and other administrative data

Dr. Rog provided technical direction on all aspects of the evaluation and was a central author on all reports and briefs.

PRINCIPAL INVESTIGATOR | Culture of Health Progress Report | Robert Wood Johnson Foundation (RWJF)

The goal of this project was to assess the uptake and spread of RWJF's Culture of Health Initiative by various groups. The evaluation included several tasks to better define a Culture of Health, develop tools to track its spread in different mediums, and learn how various organizations are operationalizing its concepts. Westat interviewed RWJF staff and leadership, grantees, housing authorities, strategic partners, organizations identified by RWJF as performing Culture of Health-like work, health department directors, and county health commissioners. In addition, project staff managed an expert advisory committee, produced a long-term evaluation plan, and conducted a bundled evaluation of illustrative projects, to help the client better understand progress in achieving a Culture of Health and to provide guidance on the future direction of the evaluation.

PRINCIPAL INVESTIGATOR | Washington Youth and Families Fund (WYFF) Systems Initiative Evaluation | Bill and Melinda Gates Foundation (BMGF)

Westat conducted a 10-year longitudinal evaluation of the Gates Foundation's Washington Families Fund Systems Initiative. The purpose of the initiative was to change the overall homeless service systems in three local counties to increase coordination and data-driven decision making among local service providers such that they can reform their systems to prevent family homelessness among those at risk and, for those who experience homelessness, facilitate rapid re-entry into housing and linkage to needed services and economic opportunity. Westat's evaluation was a comprehensive examination of the process and outcomes of the initiative in all three counties. The evaluation included (1) a systems component, in which Westat is tracking WFF implementation, changes that occur in the system, and aggregate family outcomes; (2) an organizational component involving case studies of selected providers in each county; (3) a family impact component involving longitudinal data collection for two cohorts of families (baseline and later), to examine the extent to which system changes affect families' experiences and outcomes; and (4) a cost

component to examine short- and long-term costs of a coordinated systematic response to family homelessness.

Dr. Rog guided all technical decisions related to the longitudinal mixed-methods design, its implementation, and its analysis.

PRINCIPAL INVESTIGATOR | Healthy Schools Program (HSP) Randomized Controlled Trial | JPB Foundation

The HSP was established to support schools in creating environments where physical activity and healthy eating are encouraged and accessible before, during, and after school. Westat's evaluation examined and compared two versions of the HSP. The On-Site Support Model, targeting schools in high-poverty areas, provided access to all resources on the Healthier Generation website, including toolkits, step-by-step instructions, and access to funding opportunities. The Online Model was available to all schools since 2007 but did not provide program management. Phase I of the evaluation used a randomized experimental design to compare implementation and impact of the two models in 90 elementary schools. The project team compared implementation and intensity of the two models and estimated their relative effect on school wellness policies and practices. A cost-effectiveness comparison of the two models was also conducted. Phase II examined the impact of program version on student obesity using a retrospective quasi-experimental methodology.

PRINCIPAL INVESTIGATOR | Evaluation of Healthy Schools Portfolio | Robert Wood Johnson Foundation (RWJF)

For a formative and outcome evaluation of the Healthy Schools Portfolio, Westat developed and implemented a methodology and measures to track the extent to which the projects, individually and as a whole, achieve desired outcomes. The evaluation focused on three projects funded under the Healthy School Environments Initiative, which sought to advance systemic changes that embed health in prekindergarten through 12th grade school environments. The project team also examined implementation of other initiatives and investments within this portfolio. The implementation evaluation included document reviews, grantee interviews, and site visits. The outcome evaluation included similar methods as well as a review of policies and practices.

Dr. Rog provided technical direction on all aspects of the study and was a central author on project reports and briefs.

SENIOR ADVISOR | Systematic Screening and Assessment of Community Pharmacy Strategies to Address Heart Disease and Stroke Prevention | Centers for Disease Control and Prevention (CDC)

The purpose of this project was to identify community pharmacy-based interventions for hypertension control that are promising, feasible for replication, and evaluable using rigorous methods. Westat used the Systematic Screening and Assessment method to solicit nominations of successful programs, develop screening criteria, recruit programs and interventions, and prepare program descriptions. Project staff convened an expert panel to select a subgroup of programs for further assessment and conducted site visits to determine their evaluability. A second expert panel review identified promising programs that are likely to be ready for rigorous evaluation. Westat also developed a dissemination plan for products such as factsheets, presentations for leadership briefings and conferences, an executive summary report, and infographics

Dr. Rog provided technical guidance on all aspects of the project.

PRINCIPAL INVESTIGATOR | Evaluation of the Bureau of Justice Assistance Sexual Assault Kit Initiative (SAKI) | National Institute of Justice (NIJ), U.S. Department of Justice (DOJ)

Westat assessed the Bureau of Justice Assistance's (BJA's) Sexual Assault Kit Initiative (SAKI) to prepare for a subsequent comprehensive outcome evaluation. The study included (1) a process evaluation and impact assessment of 5 advanced SAKI sites; (2) an evaluability assessment of 17 sites, to determine their readiness to participate in an evaluation and develop a comprehensive evaluation plan; and (3) analysis of a subset of unsubmitted SAKI cases to identify how characteristics of incidents, offenders, and victims are associated with case processing decisions and outcomes. The mixed-methods approach included quantitative analysis of administrative data and qualitative coding and analysis of document reviews, site visit observations, and interviews. Westat provided ongoing feedback to NIJ, BJA, the SAKI technical assistance provider, grantees, and other stakeholders.

Dr. Rog provided technical guidance on all aspects of the study, with more direct involvement in the evaluability assessments and the design of the comprehensive evaluation.

PROJECT DIRECTOR | Assessment of the RWJF Culture of Health (COH) | Robert Wood Johnson Foundation (RWJF)

Westat developed two sampling frames of RWJF grantees: (1) those with active grants of \$1 million or more, those with long-term relationships with RWJF, and new grantees outside the mainstream of healthcare and (2) active grantees with grants of less than \$1 million. Approximately 150 grantees from the first frame were selected for interviews, while grantees on the second frame were invited to complete a brief web survey. Data collection focused on grantee familiarity with RWJF's COH Vision and Action Framework and its influence on their thinking, activities, and plans. Westat also examined grantee websites. The Westat team analyzed the data by organization and wrote a topline report highlighting key findings.

PROJECT DIRECTOR | Cross-Site and Impact Evaluation of Mobilizing Action for Resilient Communities (MARC) Initiative | Robert Wood Johnson Foundation (RWJF)

The overarching goal of this 3-year, multisite evaluation was to understand and assess the effectiveness of multisector community efforts for addressing adverse childhood experiences and promoting health and well-being among children and families. The evaluation examined the extent to which MARC achieved its intended outcomes within and outside individual communities. The evaluation involved 14 communities in 13 states; the Health Federation of Philadelphia, the national coordinating agency for MARC; and two online networks that promoted this work. For each community, Westat conducted an evaluability assessment to determine the key components of its action model, developed and/or refined the community's logic model, and helped identify appropriate outcome measures. Westat also conducted a two-phase Social Network Analysis and Outcome Harvesting within and across the 14 communities to determine the accomplishments that had been achieved.

Dr. Rog created the multi component study design, and led all study components, with particular emphasis on the evaluability assessment and Outcome Harvesting components.

PRINCIPAL INVESTIGATOR | Evaluation of Los Angeles County's Strategies to Expand and Enhance Services provided through Permanent Supportive Housing | Los Angeles County Chief Executive Office

Strategy D7 (Permanent Supportive Housing) was one of 51 strategies funded through Measure H, a ballot initiative in Los Angeles County to prevent and combat homelessness. D7 aims to improve

access to and enhance the provision of services in permanent supportive housing (PSH). Westat, in collaboration with Dr. Suzanne Wenzel, conducted a mixed-methods evaluation of D7's implementation and its effects on the services provided through new and existing PSH programs. The study involved analysis and synthesis of extant county administrative data with qualitative data collected through key informant interviews with policy officials and providers and focus groups with staff and individuals served through PSH.

PRINCIPAL INVESTIGATOR | Evaluation of Los Angeles County's Strategies to Expand and Enhance Rapid Re-Housing Services for Multiple Populations | Los Angeles County Chief Executive Office

Westat, in partnership with Katharine Gale, evaluated the implementation of Strategy B3, Los Angeles County's effort to improve and expand rapid re-housing through Measure H. The mixed-methods evaluation aimed to understand the dynamics in the operation and outcomes of rapid re-housing in Los Angeles through collection of qualitative data from a broad array of sources. Data collection included a review of key documents and quarterly data; interviews and focus groups with a range of stakeholders, including administrators of the key funding agencies, directors of agencies providing rapid re-housing, front line staff from these programs, and clients served through these programs; and analysis of an integrated administrative database.

PRINCIPAL INVESTIGATOR | Evaluability Assessment for the Robert Wood Johnson Foundation's Vulnerable Populations Portfolio | Robert Wood Johnson Foundation (RWJF)

Westat provided evaluation and capacity-building support to assess the evaluation readiness and needs of RWJF's Vulnerable Populations grantees. Westat conducted approximately 25 evaluability assessments, each of which included document reviews, approximately 15 key informant interviews, focus groups and minigroups with program participants and staff, and site visits. Westat was also responsible for providing the grantee capacity-building support identified through the assessments and for supporting RWJF in prioritizing grantees for subsequent evaluations, identifying the scope of the evaluations, and planning and conducting the evaluations.

PROJECT DIRECTOR | National Heritage Area (NHA) Evaluation Project | National Park Service (NPS)

An NHA is a geographic area designated by Congress as significant in the nation's history due to its unique natural, cultural, historic, and recreational resources. Under multiple contracts, Westat evaluated NHAs to (1) assess the local management entity's progress in accomplishing the purposes of the NHA-authorizing legislation and achieving the goals and objectives of the NHA's approved management plan; (2) analyze the investments of Federal, state, tribal, and local government and private entities in each NHA to determine investment impact; and (3) review the NHA's management structure, partnership relationships, and funding to identify components critical for sustainability. Variations in NHA size, complexity, and program goals required creative application of a uniform methodology across sites.

PROJECT DIRECTOR | Washington Families Fund High-Need Families (HNF) Initiative | Washington Families Fund (WFF)

The WFF's HNF initiative was a coordinated, intensive housing and services model for high-need families in the State of Washington. Westat assessed the extent to which the initiative was successful in helping families connect with community-based services, decrease their use of high-cost services, and achieve stability. The evaluation had implementation and outcome components and continued over a 6-year period. Westat led the development of a baseline family assessment tool and a 6-month followup tool, development of a framework and measures for assessing site

implementation of the model, and the design and implementation of a study of the effectiveness and costs of the demonstration.

PRINCIPAL INVESTIGATOR | New York City Mayor's Office for Economic Opportunity (NYC Opportunity) Program Evaluation | New York City Mayor's Office for Economic Opportunity (NYC Opportunity) (previously named the Center for Economic Opportunity)

Beginning in 2007, Westat and a subcontractor were selected to lead evaluations for about 35 of the city's anti-poverty programs. These included a quasi-experimental outcome evaluation of Teen ACTION, an after-school service learning program; a preliminary assessment of outcomes for the Nursing Career Ladder Registered Nurse Program; an outcome evaluation of an internship program designed to increase labor force preparation for disconnected youth; and estimation of cost savings (net return to taxpayers) associated with three employment programs for low-income workers. In 2012, NYC Opportunity again selected the Westat team as part of an approved pool of research firms that would continue to support this work. The Westat team carried out studies of 16 city initiatives, including an implementation study of a universal pre-kindergarten program, impact studies of workforce development and youth literacy programs, an evaluation of an arts education program for justice-involved youth, and a study of the initial rollout of NYC's municipal identification program.

PROJECT DIRECTOR | Washington Families Fund High-Level Service Model (HLSM) Initiative | Washington Families Fund (WFF)

The WFF's HLSM initiative was a coordinated, intensive housing and services model for high-need families in the State of Washington. Westat assessed the extent to which the initiative was successful in helping families connect with community-based services, decrease their use of high-cost services, and achieve stability in their lives. The evaluation had both implementation and outcome components and was expected to continue over a 6-year period. Westat led development of a family assessment tool, initial reviews of the design and early implementation of grantee sites, development of a framework and measures for assessing site implementation of the model, and design of a study of the effectiveness and costs of the demonstration, conducted in subsequent years. The evaluators collaborated with WFF staff, an evaluation advisory committee, HLSM grantees, and other stakeholders in all aspects of evaluation design and development.

PROJECT DIRECTOR | Homeless Families Health Study | Oak Foundation

The Oak Foundation awarded a planning grant to the University of Massachusetts Medical School and Westat to conduct a landscape assessment of family homelessness in the greater Boston area. Collaborating with the Massachusetts Department of Housing and Community Development and the Massachusetts League of Community Health Centers, the project team systematically assessed the existing configuration and operation of the homeless service system in metropolitan Boston and explored opportunities for linking with the community health system and other mainstream systems to foster service access and residential stability for homeless families. The team convened a steering committee of key state and local officials that developed next steps based on the findings.

PROJECT DIRECTOR AND PRINCIPAL INVESTIGATOR | State of Family Homelessness in Massachusetts | Boston Foundation

Westat developed a report examining changes in family homelessness over a period of 8 years. The project involved a landscape assessment to examine changes in the size and nature of the population experiencing family homelessness and how these changes related to the assistance and programs provided, as well as the overall context. In addition, the report compared Massachusetts, and Boston in particular, to other areas of similar composition.

Dr. Rog guided all aspects of the landscape assessment and its reporting.

PRINCIPAL INVESTIGATOR | Global Nutrition Strategy Measurement, Learning, and Evaluation (MLE) Partner | Bill and Melinda Gates Foundation (BMGF

Westat partnered with the BMGF to improve the quality, timeliness, and use of evidence in strategic decisionmaking by the foundation's Nutrition Program Strategy Team. Work under the contract covered the four main initiatives of the BMGF's global nutrition strategy: (1) research on new and potential interventions in intrauterine growth restriction to promote healthy growth; (2) projects related to promoting and improving breastfeeding and complementary feeding practices; (3) investments to address micronutrient deficiencies; and (4) activities designed to influence nutrition policy and leverage resources. The work was guided by a framework of decision questions that had to be addressed between 2012 and 2016. Westat developed a crosswalk linking the decision framework to key investments, supported the 2014 annual strategy review and planning process, and provided MLE-related technical assistance to one of the foundation's grantees, the Global Alliance for Improved Nutrition.

Dr. Rog was the principal investigator.

PROJECT DIRECTOR | Evaluation Plan for Dental Therapy | Robert Wood Johnson Foundation (RWJF)

Westat developed a plan for evaluating the implementation, outcomes, and economic viability of adding one or more dental therapists (a midlevel dental provider performing preventive, basic restorative, and some intermediate restorative procedures) to a dental practice. This evaluation plan could be tailored to the program, practice, and community context, particularly to help new programs incorporate evaluation early in development. In addition, the plan suggested a set of existing standardized outcome measures to build a common base of knowledge. Unlike earlier evaluations, which focused on the extent of dental therapist training, evaluations following this plan will focus on implementation of dental therapy programs and outcomes of the practices that implement them.

PRINCIPAL INVESTIGATOR | Voices from the Community: Using Focus Groups to Identify Factors Affecting Healthy Weight | Robert Wood Johnson Foundation (RWJF)

Westat conducted rapid-turnaround focus groups with adults and youth to explore and understand cultural and community perceptions and issues related to healthy weight in some of the most vulnerable populations (African Americans, Hispanics, and Native Americans).

PRINCIPAL INVESTIGATOR | UNICEF-DFID Program of Cooperation (PoC) Evaluability Assessment | UNICEF

Westat conducted an evaluability assessment of the PoC between the U.K. Department for International Development (DFID) and UNICEF, to determine the PoC's state of evaluability and to suggest concrete ways of improving its evaluability. The project involved interviews with 30 stakeholders and a comprehensive desk review in order to suggest, where necessary, enhancements to the PoC's program logic and actions to ensure a shared understanding of the global program logic among key stakeholders throughout the organization.

PRINCIPAL INVESTIGATOR | Design for an MLE Hub for the Global Nutrition Strategy | Bill and Melinda Gates Foundation (BMGF)

Westat assisted BMGF staff in creating and developing the Measurement, Learning, and Evaluation contract (MLE Hub) for its Nutrition Strategy Area, including drafting a detailed statement of work and designing the structure for a 5-year engagement with BMGF. The MLE Hub brought new insights to the field of nutrition, grantees, and the BMGF Strategic Program Team during annual

planning and review (progress measurement), portfolio correction and decision making (answering high-priority learning questions and publishing decision analytics), and assessment of successes and learning at the culmination of the strategy period (through synthesis of grantee results reports, grantee-led evaluations, and new scientific knowledge).

PRINCIPAL INVESTIGATOR | Poverty and Service Delivery in Suburban America | Office of the Assistant Secretary for Planning and Evaluation, U.S. Department of Health and Human Services (HHS)

The project was aimed at understanding poverty and service delivery in suburban America, including how the dynamics of suburban poverty might differ from those in rural and urban communities and whether service models might have to be tailored to meet these differences. Westat prepared a framing paper that reviewed and synthesized research on poverty in suburbia, analyzed demographic characteristics and service needs of those living in poverty in the suburbs, and identified information and research needed to more fully understand and guide efforts to address suburban poverty. Westat also planned and hosted a meeting of scholars, practitioners, policy experts, and government officials to identify research and policy changes. In addition, Westat produced two papers that delved deeper into suburban typologies and the role of racial segregation.

PRINCIPAL INVESTIGATOR | Evaluation of the Robert Wood Johnson Foundation Public Health Law Initiative | Robert Wood Johnson Foundation (RWJF)

The Rockville Institute, Westat's nonprofit affiliate, evaluated two RWJF programs: the Public Health Law Research (PHLR) program, which enables legal and public health researchers to come together in a way that traditional public health and law funding sources have not supported, and the Public Health Law Network (PHLN) program, designed to provide guidance, training, and education to researchers who want to explore this field. The Rockville Institute assessed each program's structure, implementation (including activities and outputs), and short-term outcomes over a 4-year period. The project included a review of background documents, key informant interviews, a review of PHLR proposals and grantee interviews, surveys, and development of recommendations on how each program was positioned for a possible next phase.

PRINCIPAL INVESTIGATOR | Medical Respite Care for Persons Experiencing Homelessness | Office of the Assistant Secretary for Planning and Evaluation, U.S. Department of Health and Human Services (HHS)

Westat led a retrospective study to evaluate the costs, quality, and outcomes of respite care for homeless people, specifically whether it leads to fewer or shorter hospitalizations compared to routine services and whether there are relative long-term savings associated with respite care. In collaboration with the Boston Health Care for the Homeless Project, Westat convened an expert panel to inform development of a retrospective study design. To identify sites that best met the outcome criteria established by the panel, Westat conducted evaluability assessments of 12 medical respite programs and partnering hospitals, including key informant interviews and extensive document reviews. Five sites were selected for the full study, in which Westat collected retrospective patient data from respite programs and associated hospital systems and conducted site visits to observe program operations and interview key informants.

PRINCIPAL INVESTIGATOR | National Collaborative for Trauma-Surviving Homeless Children | Substance Abuse and Mental Health Services Administration (SAMHSA)

Supported by a SAMHSA Category II grant under the National Child Stress Initiative, the collaborative was a collaboration between the National Center on Family Homelessness and the Trauma Center. The Rockville Institute conducted an evaluation of the collaborative's initiative to

develop best practices on the handling of trauma-related issues by homeless family shelters and to disseminate these practices and train homeless shelters to use them. Three case studies were conducted to evaluate success in persuading shelters to adopt trauma-sensitive practices and to examine factors that influenced whether organizational change occurred. Data collection and analysis were guided by a theoretical model based on the literature on organizational change and adoption of innovations. Data collection included document reviews, program observations, and telephone and site visit interviews with collaborative staff, leaders at each shelter organization, program managers, and frontline staff at each shelter. Dr. Rog was the principal investigator.

PRINCIPAL INVESTIGATOR | Mediation for Homelessness | Substance Abuse and Mental Health Services Administration (SAMHSA)

In collaboration with another contractor, the Rockville Institute examined the role of conflict mediation in addressing homelessness among people with mental illness. The purpose of the project was to provide preliminary evidentiary data on the promise of conflict mediation as an intervention to forestall homelessness for those at imminent risk of losing their housing. The project had two components: an examination of the use and consequences of conflict mediation among 30 to 50 people with mental illness and a review of the implementation and value of conflict mediation as a tool for service providers.

PRINCIPAL INVESTIGATOR | Access to Mainstream Services | U.S. Department of Housing and Urban Development (HUD)

Westat was part of a team that conducted a descriptive evaluation to gain (1) an understanding of how the practices of homeless providers and mainstream representatives affect access to mainstream benefits for homeless clients, and how this varies among disabled adults, nondisabled adults, and families, and (2) an understanding of how communities are using their resources and developing processes and structures to remove barriers to mainstream services for homeless clients. The evaluation consisted of document reviews, site visits and related discussions, analysis of administrative data, and secondary analysis of key datasets that might provide greater understanding of the benefits received by homeless families and adults, factors that affect access, and barriers confronted.

PRINCIPAL INVESTIGATOR | Massachusetts Homeless Families Project | University of Massachusetts Medical School

The purpose of this study, conducted by the Rockville Institute, was to examine the pathways families follow in exiting shelters. A particular focus was the role that services play in the exit process, as well as other factors that facilitate or block families from leaving homelessness successfully. The study used data gathered through interviews with the full census of families entering shelters in Worcester, MA, over a 9-month period. The analysis was designed to determine what distinguishes families who are able to exit homeless shelters within 6 months from those who become "stuck."

PRINCIPAL INVESTIGATOR | Cross-Site Evaluation of the Prevention of Family Violence Initiative | Anthem Foundation of Ohio

The Anthem Foundation of Ohio funded four counties to develop broad cross-sector coalitions to plan and implement efforts for preventing multiple forms of family violence (e.g., child abuse, intimate partner violence, and elder abuse). The Rockville Institute conducted a cross-site outcome evaluation of a 2-year extension phase of the initiative. This phase assessed the extent to which the counties maintained and "empowered" their coalitions; created sustainable changes in the organizations, systems, and communities; and leveraged resources to sustain their operations and expand their activities. Data collection included document reviews, as well as interviews with local

coalition staff, coalition members, community members, and representatives of local agencies engaged in the coalitions' change efforts.

PRINCIPAL INVESTIGATOR | Evaluation of the DC Achievers Initiative | Bill and Melinda Gates Foundation (BMGF)

Westat evaluated a comprehensive 15-year scholarship program available to students from six high schools (three public and three public charter schools) in two of the neediest sections of the district. Project staff collected qualitative data through key informant interviews (with principals, Achievers coordinators, and other staff preparing students for postsecondary education) and focus groups (with teachers, students, and parents) to describe how well the initiative was implemented and to understand the culture of college-going in these and comparison schools. Westat produced several reports that will be used by the Gates Foundation to make program adjustments.

PRINCIPAL INVESTIGATOR | Evaluation of Prevention Services in Washington, DC | DC Department of Human Services (DHS)

Westat is working with DHS to develop and test a prevention tool that can accurately target effective services to families at risk for homelessness. The work involves tailoring a tool empirically developed for New York City families to include risk factors that differ for DC families. Westat is also examining the effectiveness of prevention services using a rigorous quasi-experimental design (i.e., regression discontinuity design). In addition, project staff are comparing the efficiency of this method with two other targeting methods: (1) worker ratings of the likelihood of families becoming homeless and (2) the New York City prevention tool.

Dr. Rog's primary responsibilities included all technical aspects of the study, including guiding the development and implementation of the design, reviewing analyses, writing the report, and presenting findings to the client.
